

It is observed that all the departments have sufficient number of laboratory equipment for conducting experiments as per VTU syllabus.



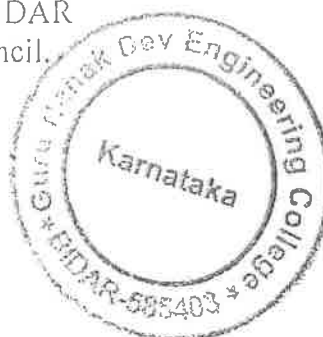
